In consideration of being allowed to participate in the Calgary West Little League Association ("CWLL") baseball program and related events and activities, the undersigned acknowledges, appreciates, understands, and agrees that:

1. Participation includes possible exposure to and illness from COVID-19. If, however, I observe any unusual or significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest CWLL official immediately; and,

I, for myself, and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS the CWLL and their officers, directors, officials, agents, employees, other participants, owners, and lessors of premises used to conduct CWLL events ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, in connection with exposure, infection and/or spread of COVID-19 related to utilizing CWLL's services and/or premises WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
